**Common Terms Agreement dated 30 July 2002 between, among others, the Issuer, AWS and Deutsche Trustee Co Ltd (the "Security Trustee") (the "Common Terms Agreement")**

Capitalised terms not defined in this certificate have the meaning given to them in the Common Terms Agreement.

1. We refer to the Common Terms Agreement. This is a Compliance Certificate.
2. We confirm that in respect of the most recently occurring Calculation Date (30 September 2024) the financial ratios are:
  - (a) the Class A RAR is 68.8%;
  - (b) the Senior RAR is 68.8%;
  - (c) the Class A ICR is 4.2:1;
  - (d) the Class A PMICR<sup>1</sup> is N/A;
  - (e) the Senior PMICR<sup>1</sup> is N/A;
  - (f) the ratio of Net Cash Flow minus Capital Maintenance Expenditure to Class A Debt Interest is 2.3:1;
  - (g) the Conformed Class A PMICR is 1.6:1;
  - (h) the Conformed Senior PMICR is 1.6:1;
  - (i) the Additional Senior RAR is 68.8%;
  - (j) the Additional Conformed Senior PMICR is 1.6:1;
  - (k) the Additional Conformed Senior Average PMICR is 1.5:1;(together the "**Ratios**")

We confirm that each of the above Ratios and each of the Senior Average PMICR<sup>2</sup>, Class A Average PMICR<sup>2</sup>, Conformed Senior Average PMICR, Conformed Class A Average PMICR and Additional Conformed Senior Average PMICR have been calculated with respect to the Test Periods for which they are required to be calculated under the Common Terms Agreement and have not breached the Trigger Event Ratio Levels and have not caused Paragraph 20 (Ratios) of Part 2 of Schedule 7 (Events of Default) to be breached.
